Referral Partnership Agreement

Responsibility of the Parties

TERMS

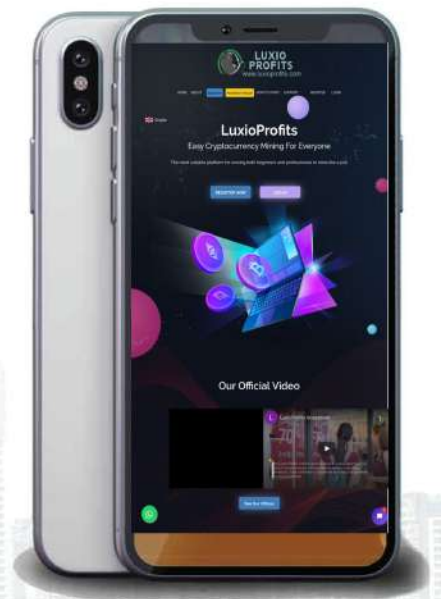
